# Actions of the Michigan Bird Records Committee for 2018

This is the 29<sup>th</sup> report of the Michigan Bird Records Committee (MBRC), covering the committee's actions during the year 2018.

In 2018, the MBRC consisted of regular members Jeff Buecking (Genessee Co.), Louis Dombroski (Bay Co.), Matt Hysell (Berrien Co.), Brad Murphy (Oakland Co.), Marc North (Eaton Co.), J.D. Phillips (Marquette Co.), and Scott Terry (Livingston Co.), and alternate members Lyle Hamilton (Livingston Co.) and Darrell Lawson (Charlevoix Co.). Dombroski chaired the committee, and Adam M. Byrne (Clinton Co.) continued serving as secretary, though as a non-voting member.

This article presents the results of all final votes for records taken in 2018. In 2018, the MBRC finalized votes on 143 records, with 98(68.5%) of these records resulting in acceptance ("acceptance" meaning that at least one individual reported was accepted, even if at a broader taxonomic level than initially reported). We also voted to reconsider one Blue Grosbeak (Passerina caerulea) record, resulting in the acceptance of an additional individual for a previously accepted record.

Records reviewed include those submitted directly to the MBRC, and some records submitted to eBird.

Several species had a change in their occurrence status at the end of 2018:

The status of Eurasian Wigeon (Mareca penelope), Mississippi Kite (Ictinia mississippiensis), and Blue Grosbeak changed from Casual to Regular. They will remain on the review list through 2021, at which time, if still Regular, they will be eligible to come off the review list.

The status of Mew Gull (Larus canus) and Fork-tailed Flycatcher (Tyrannus savana) changed from Accidental to Casual.

The status of Neotropic Cormorant (*Phalacrocorax brasilianus*) and Bell's Vireo (*Vireo bellii*) changed from Casual to Accidental.

White-faced lbis (*Plegadis chihi*) and Loggerhead Shrike (*Lanius ludovicianus*), having maintained Regular status for three years since being upgraded from Casual status, have been removed from the review list effective 1 January 2019. However, potentially problematic ibis, such as those not in alternate plumage, will still be reviewed if requested by seasonal survey compilers or eBird reviewers. With this change, *Plegadis* ibis also exits the review list, with the same caveat that seasonal survey compilers or eBird reviewers can send reports to the MBRC at their discretion.

At our December 2018 meeting, we adopted a new policy regarding remote attendance at meetings. Previously, attendance at meetings was required to be in person. A motion was made to adopt a policy that states: "The Chairperson can allow one member to attend meetings remotely for reasons of travel distance or extenuating circumstances in 2019 as a trial to be re-evaluated in one year." After considerable discussion, the committee voted 5-3 to adopt this policy.

The information provided for each of the following records is: name of species (or other taxon); the committee's vote tally (When the vote is said to have gone to the second round, that means that initially the record received a vote of 4-3 or 5-2, in which case a second vote is held after the record is discussed at a meeting of the MBRC); an inventory of the documentation received (For accepted records, the observers associated with the documentation are listed. If known, the person who first found the bird or birds is also listed and underlined, whether they submitted documentation or not); and information on the dates, location, and number of birds observed.

Two males at Nayanquing Point State Wildlife Area, Bay Co. were observed on 11 April 2017, with one seen through 21 May (64th state record, 4th county record). One individual was accepted in 2017. There was initially some concern about whether photographs showing both birds together adequately ruled out the possibility of a hybrid for the second bird, but a majority of the committee found that the photos were adequate for the acceptance of both individuals; the second individual was accepted in 2018.

Photos from 23 July only showed two juveniles, leaving most members unwilling to endorse an additional four young, which were not accepted with a 3-4 vote.

identification, which included corresponding with David Sibley about the bird under review. One feature on this first-year bird supporting this identification was the golden-green tone to its wing coverts (rather than bluish as in Glossy Ibis). An additional feature captured in excellent photographs was that the underside of the lower mandible was extensively pinkish, as illustrated by Sibley (2014) (rather than blackish as in Glossy Ibis); in the personal communication with the observer, Sibley stated that this last feature was "a field mark that needs more testing". One concern about this new field mark was the uncertainty of how it would appear on hybrid individuals. General consensus remains that juvenile *Plegadis* ibis are often best left unidentified, leading to a 0-7 vote to not accept as a White-faced Ibis.

Some committee members found this sufficient to rule out White-faced Ibis or hybrids, while others were wary of identifying any juvenile birds as Glossy Ibis, reasoning that birds that don't show red bare parts in immaturity may develop this color as they get older. Both birds were not accepted as Glossy Ibis with a 3-4 vote.

One at Flushing, Genesee Co. on 3-18 June 2018 (6th state record, 1st county record) was an especially amazing and fortuitous discovery, since all previous Michigan sightings occurred within sight of one of the Great Lakes, which serve as a barrier for many vagrant passerines, aiding in their detection. Identified to the nominate subspecies *T. s. savana* by some, the committee rejected the identification to that level by a vote of 0-7. The most useful feature for separating the widespread nominate subspecies from the more northerly nesting *T. s. monachus* is the presence of emargination in the outer three primary tips in adult males (McCaskie and Pattern, 1994). Several photos showing the spread wing of the Genesee Co. bird reveal no emargination in the outer primaries, making

assigning the bird to subspecies difficult, since other features such as the extent of the white nape collar and the darkness of the back color would be especially difficult to judge on this worn individual.

#### Blue Grosbeak (Passerina caerulea)

vote: 7-0

photo files: Sandra LaFaut

In 2017, the committee accepted a record of two birds (one male and one female) present 12 August – 1 September 2017 at Pointe Mouillee State Game Area, Monroe Co. (Dombroski 2018). In 2018, a request was made and unanimously approved to reconsider this record. The request pointed out that the committee had overlooked photos from one observer taken on 16 August 2017 that showed a female with significant blue feathering in the face that was lacking in all the others. This action resulted in this second distinctive female being added as a third individual to this record.

#### Blue Grosbeak (Passerina caerulea)

vote: 7-0

One singing male at Novi, Oakland Co. on 28 May - 20 August 2018 (39th state record, 3<sup>rd</sup> county record).

#### **RECORDS NOT ACCEPTED**

# Black-bellied Whistling Duck (Dendrocygna autumnalis)

vote: 4-3 in the second round one description

This description was of a bird that flew over a highway in Isabella Co. on 10 June 2017. It was described as having large patches of white on the upper sides of its wings and prominent black on its underside, but not on the breast and neck, and with feet that extended beyond the tail. Some committee members were satisfied that this description ruled out all other species, but others were concerned that Muscovy was not ruled out.

# Black-bellied Whistling-Duck (Dendrocygna autumnalis)

vote: 0-7

one description

An eBird report of a bird on 27 May 2018 at Clam Lake, Antrim Co. mentioned bright "pink red legs" and much white showing on wings in flight, but didn't mention where the white on the wings was or other details

such as the belly color or bill color, and thus did not rule out Common Merganser (Mergus merganser), among others.

#### Barnacle Goose (Branta leucopsis)

vote: 1-6 for 2 birds one description

Two birds seen from 22 October – 12 November 1979 at Fennville, Allegan Co. were described reasonably well in original field notes, but most committee members were concerned about the possibility that these birds could have escaped from captivity.

#### Eurasian Wigeon (Mareca penelope)

vote: 0-7 one description

One eBird report for 24 May 2014 at Pointe Mouillee State Game Area, Monroe Co. was written more than three years after the observation and was described too briefly for acceptance.

## Eurasian Wigeon (Mareca penelope)

vote: 0-7 one description

An eBird description of a bird on 15 March 2018 at Pleasant Lake, Washtenaw Co. did not contain enough detail for acceptance.

# Eurasian Wigeon (Mareca penelope)

vote: 1-6 one description

An eBird report from 22 April 2018 at Maple River State Game Area, Gratiot Co. did not include information on the underparts coloration, so most committee members were not satisfied that a hybrid with American Wigeon was ruled out.

# King/Common Eider (Somateria spectabilis/mollissima)

vote: 2-5 in the second round one description

A bird seen on 2 Dec 2017 at Munising, Alger Co. was reported as a male Common Eider by two observers who sent in a joint description. The record initially received some support for acceptance as a Common Eider based on the description of the bird as appearing unusually large

for a duck, diving repeatedly, and "revealing the long thin vertical V of yellowing beak blending into solid black cap. To either side of the V, bulging white cheeks". A majority of the committee, however, remained concerned that the account of the sighting was written more than a week later, and that some features, such as the solid black cap, were not noted by both observers, that the rest of the bird was not described in enough detail (though described as being largely white, there was no mention of what parts of the bird's plumage were white) and that the description did not rule out leucistic individuals of other species besides eiders.

## Barrow's Goldeneye (Bucephala islandica)

vote: 1-6 one description

This was a historical sighting from 5 June 1982 at Bois Blanc Island, Mackinac Co. vividly remembered by the observer as a "purple-headed male Barrow's Goldeneye with a distinct white crescent in front of the eye" though head shape was not noted. Without a more detailed description of the head pattern and no mention of other field marks such as the extent of white in the wing coverts, the committee did not think the documentation ruled out a hybrid with Common Goldeneye (B. clangula).

#### Barrow's Goldeneye (Bucephala islandica)

vote: 0-7 one description

An eBird entry of a female seen on 16 January 1988 was described as having a short, all yellow bill and a head shape consistently different from Common Goldeneyes present even after dives. The lack of further detail, concern over the reliance on the unreliable "yellow bill" field mark, and the 30-year gap between the sighting and the writing of the description were reasons cited for its rejection.

# Barrow's Goldeneye (Bucephala islandica)

vote: 0-7 photo files

Several photos of a female goldeneye swimming with Common Goldeneyes taken on 17 November 2017 at the Boyne City sewage ponds, Charlevoix Co. were inconclusive. Though the bird had a mostly yellowish bill that in some photos appears small, the head shape did not give a consistent impression that fit Barrow's Goldeneye.

#### Barrow's Goldeneye (Bucephala islandica)

vote: 0-7 for 2 birds

one description and photo files

Two birds were reported on 18 January 2018 at Kewadin Beach, St. Clair Co. The photos appear to show Common Goldeneyes, one with some yellow on the bill, which may have led to the misidentification.

#### Barrow's Goldeneye (Bucephala islandica)

vote: 0-7

one description and photo files

One was female reported on 19 February 2018 in Harrison Charter Twp., Macomb Co. Photos of this bird showed a goldeneye with a yellow-tipped bill and a steep forehead that was suggestive of Barrow's Goldeneye, but the size and shape of the bill was thought to be closer to Common Goldeneye.

### Western Grebe (Aechmophorus occidentalis)

vote: 0-7

one description

One was reported at Mackinac Island, Mackinac Co. on 23 June 2018. The bird was described as a large black-and-white diving bird with a long, thin and light-colored bill. Even if this were an Aechmophorus grebe, there was insufficient detail on the facial pattern to rule out a Clark's Grebe (A. clarkii) or a hybrid. Several members, however, also were concerned that either Common Loon (Gavia immer) or Red-necked Grebe (Podiceps grisegena) could also fit this description.

# Black-chinned Hummingbird (Archilochus alexandri)

vote: 0-7

two photo files

Two photos taken on 23 July 2017 at Royal Oak, Oakland Co. show a female *Archilochus* hummingbird, but are not detailed enough to rule out Ruby-throated Hummingbird (*A. colubris*) and there was no accompanying description or explanation as to how the identification was made.

## King Rail (Rallus elegans)

vote: 0-7 in the second round two descriptions

A bird at Munuscong Bay Wildlife Management Area, Chippewa Co. on 4 and 14 June 2017 was heard only, and the description of the

vocalizations, which included both "kick - kick" notes and a grunting call, were thought not convincing enough to rule out Virginia Rail. One committee member recounted searching for this bird and finding a vocalizing, visually confirmed Virginia Rail (R. limicola) that was making a call that could have fit the description of the call described in the documentation.

#### King Rail (Rallus elegans)

vote: 0-7

one description

One described as heard at Nayanquing Point State Wildlife Area, Bay Co. on 9 July 2018 was stated to be making a grunting call, but with no further elaboration, Virginia Rail could not be ruled out.

#### King Rail (Rallus elegans)

vote: 0-7

one description

One described as heard on 2 September 2018 at Quanicassee State Wildlife Area, Tuscola Co. was described as heard only, making a clicking call slower than Yellow Rail, but this description was thought to not rule out some calls of Virginia Rail and Sora (*Porzana carolina*).

# Baird's Sandpiper (Calidris bairdii)

vote: 1-6 for 2 birds one description

An eBird report of two birds on 19 May 1974 was not accepted primarily due to the time lapse between the sighting and the posting of the report and the lack of any field notes, even though the account mentions that direct comparison was made with Least (C. minutilla) and White-rumped (C. fuscicollis) sandpipers present in the same flock.

# Red Phalarope (Phalaropus fulicarius)

vote: 2-5 in the second round one description and two photo files

A bird at Lighthouse Park, Port Huron, St. Clair Co. on 10 November 2017 was seen in flight and on the water. Some committee members found the documentation convincing, but the majority were concerned that the characteristics needed to rule out Red-necked Phalarope, (*P. lobatus*), such as the unstreaked back, could not be adequately assessed at the distance and lighting conditions involved.

#### Pomarine Jaeger (Stercorarius pomarinus)

vote: 3-4

two descriptions and two photo files

A jaeger observed on 9 October 2017 at Whitefish Point, Chippewa Co. was described as having a stocky build, a large pale-based bill, and central tail feathers that were rounded and extended only slightly. While some on the committee were satisfied with the identification, others found the photos inconclusive and thought more details were necessary to rule out Parasitic Jaeger (S. parasiticus).

#### Pomarine Jaeger (Stercorarius pomarinus)

vote: 0-7

one description

A bird on 22 November 2018 at Marine City, St. Clair Co. was seen without binoculars and from a moving vehicle and was not described in enough detail to confirm its identification as a jaeger, even at the generic level.

#### Black-headed Gull (Chroicocephalus ridibundus)

vote: 1-6

two descriptions

This report was of a bird seen on 30 November 1975 at the Whiting Power Plant, Monroe Co. This record was previously reviewed and rejected based on an a brief eBird description submitted years after the sighting. The receipt of another eBird report prompted a unanimously accepted request to review it again, but most committee members were concerned with the lack of original field notes to back up the report, leading to the same outcome.

# Slaty-backed Gull (Larus schistisagus)

vote: 3-4 in the second round one description, photo files

An adult dark-backed gull observed on 19-20 May 2017 at Whitefish Point, Chippewa Co. received support from some committee members, but a majority were concerned that an arc of white spots on the upper surface of the primaries did not extend far enough or strongly enough toward the outer primaries; that the underwing surface was too pale; and that the legs, while described as brighter pink than those of adjacent Herring Gulls, were longer than would be expected for a Slaty-backed Gull.

#### Neotropic Cormorant (Phalacrocorax brasilianus)

vote: 0-7
one description

This report was of a bird studied at an estimated distance of 400-450 m through a spotting scope on 13 July 2017 at the Whiting Overlook Park, Midland Co. The committee first voted on this record in 2017, accepting it with a vote of 6-1, but in early 2018 unanimously accepted a request to reconsider the record. The bird was described as "an obvious cormorant, with a long snaky neck, slender yellow bill hooked at the tip, and yellow bare skin at the chin" and as appearing remarkably small, about the size of a Caspian Terns and much smaller than adjacent Herring Gulls, and appearing very long tailed. Upon reconsideration, all on the committee were concerned that the initial impression that the bird was a cormorant could have been incorrect, especially given its small size, and that the description could apply to a distant female or juvenile Hooded Merganser, especially if the assessment of where the bird's tail began along with more subtle facial features were made incorrectly.

#### Plegadis ibis (Plegadis sp.)

vote: 1-6 one description

A bird seen on 12 May 2018 near Manchester, Washtenaw Co. was noted as being seen only briefly, mostly flying away, with the view partly obscured by trees, and without the aid of binoculars. Despite being described as having a curved bill and being roughly the size of a Great Blue Heron, the description was too sparse to compensate for the unfavorable conditions of the encounter, with one committee member suggesting that the impression of a curved bill could be caused by a Great Blue Heron carrying a stick.

# Mississippi Kite (Ictinia mississippiensis)

vote: 1-6 one description

One on 11 September 2017 in Berrien Co. was described too briefly and lacked any mention of distance or conditions to warrant acceptance.

# "Harlan's" Red-tailed Hawk (Buteo jamaicensis harlani)

vote: 2-5 in the second round one description and three photo files

An immature Red-tailed Hawk photographed on 10 May 2018 was identified as a dark intermediate morph "Harlan's" Hawk, but a majority of the committee, noting the difficulty of distinguishing this subspecies from "Western" Red-tailed Hawk (B. j. caluris), were concerned that barring on the outermost primaries, though visible in the photographs, was faint, and thought therefore that "Western" Red-tailed Hawks or intergrades could not be ruled out.

#### Ferruginous Hawk (Buteo regalis)

vote: 0-7 one description

An account of a dark morph buteo at Port Crescent State Park, Huron Co. on 2 May 2018, seen in lighting conditions described as overcast and poor, listed such features as white areas on the primaries and base of upperside of tail, and the tail appearing light underneath, features that are suggestive of Ferruginous Hawk, but do not completely eliminate all possible plumages of other dark morph buteos such as "Harlan's" Redtailed Hawk (B. jamaicensis harlani) and Rough-legged Hawk (B. lagopus). Impressions of the bird as massive, burly, and eagle-like were deemed too subjective to overrule concerns regarding the plumage description.

## Barn Owl (Tyto alba)

vote: 0-7 one description

An eBird report of one on 15 March 2018 in Ingham Co. gave no description beyond a white and tan bird seen swooping and hunting from an observer in a car, so was insufficient for acceptance.

# American Three-toed Woodpecker (Picoides dorsalis)

vote: 0-7 one description

An eBird report from Keweenaw Co. on 8 October 2017 was not described well enough to rule out Black-backed Woodpecker.

# American Three-toed Woodpecker (Picoides dorsalis)

vote: 0-7 one description

A very brief eBird description from 22 April 2018 of a woodpecker in Ottawa Co. drilling holes in a pine tree and having dusty yellow on the head and sides of neck was more likely a Yellow-bellied Sapsucker,

especially given the southern location. Three toes were stated to be clearly visible, but this does not preclude the possibility of a fourth that was not.

## Ivory-billed Woodpecker (Campephilus principalis)

vote: 0-7

one description and one photo file of specimen

A mounted specimen of an unmistakable Ivory-billed Woodpecker displayed at the North Museum of Nature and Science in Lancaster, PA has data associated with it in the museum's catalog stating it was collected "at Turtle Lake near Indian River, Northern Peninsula, Michigan, Nov. 13 1885". The information on the tag attached to the bird's leg was re-written 26 years after the bird's collection, so the committee was concerned about its accuracy, since mislabeled specimen tags have been well documented previously, and could not endorse what would be an extraordinary extralimital record for this species.

#### "Prairie" Merlin (Falco columbarius richardsonii)

vote: 3-4 in the second round photo files

A Merlin that was well-photographed on 4 May 2018 at Tawas Point State Park, losco Co. was clearly much paler than typical nominate birds seen in Michigan. Some committee members were satisfied that the overall appearance of the bird marked it as the "Prairie" subspecies, but a majority were concerned that scattered dark feathers on the head, back, and uppertail coverts indicated that it could be an intergrade with the nominate subspecies and could not support it on that basis.

#### Prairie Falcon (Falco mexicanus)

vote: 1-6 one description

A falcon at Port Crescent State Park, Huron Co. on 2 May 2018 was described as passing quickly within 6 ft over the observer's head and having dark "struts" on the trailing edge of creamy white underwing linings, and a relatively pale tail was seen too briefly to satisfy most committee members, who thought that American Kestrel (F. sparverius) and Peregrine Falcon (F. peregrinus) could at times give the impressions noted.

# Great Kiskadee (Pitangus sulphuratus)

vote: 4-3 in the second round one description and photo file

This intriguing report of what would be a first state record was of a bird seen on 4 June 2017 at Tawas Point State Park, losco Co. The single observer provided a description and one distant photo that showed the bird from underneath and behind. The observer described hearing "a two-note Kadee call several times, and a three-note kiskadee call once", and discussed how Boat-billed Flycatcher (Megarynchus pitangua) and Social Flycatcher (Myiozetetes similis) were ruled out by voice, bill size, and plumage features. A majority of the committee members were satisfied with the documentation, but some were concerned that Boat-billed Flycatcher vocalizations could sound similar, and that the description mentioned rufous on the back, which wouldn't fit either species, so the record failed to reach the threshold for acceptance.

#### Scissor-tailed Flycatcher (Tyrannus forficatus)

vote: 2-5 in the second round one description

One on 5 August 1985 in Ontonagon Co. was described as having "extreme long tail streamers" and a "pink splash on the sides and brighter pink area at the shoulders". Some committee members thought that this species is so distinctive it could be written up from memory decades later, but a majority were concerned about this time lapse and the lack of field notes, some noting that hybrids with other kingbird species were not explicitly eliminated.

## Black-billed Magpie (Pica hudsonia)

vote: 0-7 one description

A brief eBird description of a black-and-white bird with a long tail and said to be similar in size to a robin, was reported in Gogebic Co. on 7 June 2017. Members were bothered by the brief description, grossly inaccurate size estimate, and the observer's statement "Black-billed Magpie is my best guess."

# Fish Crow (Corvus ossifragus)

vote: 3-4

two descriptions, photo files, and one video file

One crow, present from 12-21 November 2017 at South Haven, Van Buren Co. was thought to sound like a Fish Crow. Members were divided on this record, but dissenters felt the vocalization in the video file sounded better for American Crow. The remaining documentation did not offer any conclusive support that could overrule the video file.

#### "Newfoundland" Veery (Catharus fuscescens fuliginosus)

vote: 2-5

one description and two photo files

The Veery involved in this record was banded on 13 September 2010 at Rouge River Bird Observatory, Wayne Co., and was clearly not typical of birds seen in Michigan, in that it was nearly or totally lacking in rufous tones and was more heavily spotted on the breast. Measurements and other plumage features ruled out all other Catharus thrushes, but most committee members were unconvinced that this bird could safely be assigned to subspecies, given the subjective nature of the characteristics used to separate them and the possibility of intergradation. The subspecies breeding in western North America, C. f. salicicolus, is stated to have a back that is "dull, moderately dark brown with a reddish tinge" (Pyle 1997); a judgment that this individual lacked reddish tones was the rationale used to rule out this subspecies, but some committee members thought this bird did have a slight reddish tinge, and even the observer reporting the bird stated that they couldn't be 100% sure of the identification.

#### Spotted Towhee (Pipilo maculatus)

vote: 1-6 in the second round photo files

One of the observers providing photos of this bird, seen on 7 April 2017 at Ishpeming, Marquette Co, referred to it as a "possible hybrid". A majority of the committee, while acknowledging that this male towhee had a very strongly patterned back and wing coverts, felt it had a significant white patch at the base of the outer primaries, which could indicate a hybrid origin, so the bird was not accepted as a Spotted Towhee on that basis.

# "Audubon's" Yellow-rumped Warbler (Setophaga coronata auduboni) vote: 0-7 one description

A Yellow-rumped Warbler seen on 19 April 2018 at Tubbs Lake Island Campground, Mecosta Co. was described as having a thick yellow patch on the chin, but with no more specific details about its extent or other details of wing, face, or breast pattern, the possibility of an intergrade with "Myrtle" Yellow-rumped Warbler could not be ruled out.

#### Western Tanager (Piranga lucovicianus)

vote: 3-4 one photo file

The one photograph provided, taken on 4 May 2018 at Traverse City, Grand Traverse Co. is of a distant predominantly yellow bird that appears to have a black back and tail. The image looks as if it were taken through a screen, and the committee was split on whether the photo was clear enough for a positive identification, with a majority thinking it was not.

### Western Tanager (Piranga lucovicianus)

vote: 0-7
one description

A bird on 5 May 2018 at Montibeller Park, Washtenaw Co. was described as having bright orange on the head, but not having a dark back, a description that could fit Scarlet or Summer Tanagers.

#### Rose-breasted Grosbeak (Pheucticus Iudovicianus)

vote: 3-4 for 2 birds, 2-5 for a  $3^{\rm rd}$  individual, and 1-6 for a  $4^{\rm th}$  individual two descriptions

During a Christmas Bird Count on 16 December 2017 near Tawas City, losco Co., four birds seen along a roadside were identified as this species. Three of the four were identified by a red bib on their otherwise black and white plumage. While the descriptions of the males could seem to fit no other species, most committee members, noting how unlikely even one Rose-breasted Grosbeak is in December, thought more details were necessary to convincingly document a flock of this species at this time of year. The only confusion species mentioned in the write-ups was Redheaded Woodpecker, leading most committee members to think that other possibilities such as Purple Finch, House Finch, or Red-winged Blackbirds (which sometimes sport reddish color on the throat) were not carefully considered.

# Blue Grosbeak (Passerine caerulea)

vote: 3-4 in the second round one description

This was a report on eBird that described a bird with "deep blue body with rusty wingbars" that gave a "sharp chink call" near a previous breeding location in Washtenaw Co. on 23 July 2017. While some

committee members were satisfied with this account from an experienced observer, a majority thought that more thorough documentation, including circumstances like distance, lighting conditions, and optics, was required for a species still on the state's review list.
